Please see below for some other highlights this semester:

## Course Sign Up –

- YOU MUST SIGN UP TWO WEEKS PRIOR TO THE START OF CLASS (We need to have time to have materials available for you at the start of class.) Sign up at <a href="https://www.ualocal434.org">www.ualocal434.org</a>.
- Classes will be cancelled one week prior to the start of class if not enough members are signed up.

## Welding Classes/Manuals

- Pre-requisite All apprentices must complete Local 434 Oxy-Fuel and Shop Safety. All members are encouraged to take this class.
- O You will be keeping track of your own welding progression in the manual you receive at your 1st welding class.
- O You will not be placed on a roster until you have completed the Local 434 Torch and Welding Safety Class **and** sent in your deposit check. You must complete this class at least one week prior to the welding class start date.
  - Make check payable to: UA Local 434 Training and mail to the Eau Claire Training Center.
- o If you need to drop a welding class that you have signed up for, you must go to the website to cancel your registration at least one week in advance in order to get your deposit check back. If you don't, your deposit check will be cashed.
- o In order to take a UA Weld Test, an ATR will need to approve you.

## Backflow/Cross Connection Re-Certification

- O You must sign up 3 weeks prior to the start of class tests need to be requested from ASSE.
- The location of the class will depend on where the highest number of members is enrolled

#### o Foreman Certification - Pre-requisite now required

- O You must be in at least your 3<sup>rd</sup> year of apprenticeship
- O You must have taken Blueprint Reading
- o Foreman Re-Certification Must attend 3 hours of class and have worked at least 1500 hours

#### NCCCO Crane Signaling Certification and Re-Certification

- O You must sign up 4 weeks in advance. Tests need to be applied for from NCCCO.
- o If your certification will be expiring in the next year, you will need to retake the practical exam to re-new your certification.
- o If you expire in the fall of 2017 you can take the class/test now, and your certification month and day won't change. (Only the year will be updated.)

# o NITC Medical Gas Re-Certification

- o Med Gas Re-Certification classes will be held at all Training Centers this semester. Must be signed up three weeks before test.
- Anyone needing to re-certify only needs to take the written open book exam.

# Course Overlaps

 Many classes run on the same nights, before you enroll please check the dates of classes to be sure they don't run on the same nights.

## Training Center Use

- o All members (including instructors) using shop must call me when arriving at and leaving the shop.
- Also call a couple days prior to using the shop to ensure that you have the correct code.
- You must sign in; please list any broken tools or untidiness that you find and clean the shop.
- o Anyone not following procedures will lose privileges to use the training center.
- o **Instructors Needed** (we would like 2 instructors for each class in each area, so that substitute teachers are available.)
  - Refrigeration Instructors needed in Mosinee
  - o OSHA Instructor needed in La Crosse
  - O Please contact me if you are able to help with any classes in any location
